# a) Status Reports

#### b) Duration of agreements

The StC decides that future GCOS CH agreements shall be concluded for a maximum duration of four years with the possibility of explicit renewal ("Befristeter Vertrag mit Möglichkeit zur expliziten Verlängerung").

#### c) Terms of Reference (ToRs) GLAMOS evaluation

With minor revisions the proposed TORs for the GLAMOS evaluation are adopted.

The Swiss GCOS Office is tasked to initiate the evaluation process and to invite GLAMOS representatives to the next StC Meeting.

#### d) Terms of Reference Euro-Climhist evaluation

With minor revisions the proposed TORs for the Euro-Climhist evaluation are adopted.

The Swiss GCOS Office is tasked to initiate the evaluation process and to invite Euro-Climhist representatives to the next StC Meeting.

The StC decides to entrust Prof. Georgina Endfield (University of Liverpool, UK) and Prof. David Nash (University of Brighton, UK) with the evaluation of Euro-Climhist.

#### b) Call for Proposals 01/2018: Lessons learnt

The StC takes note of the lessons learnt from the Call for Proposals 01/2018.

#### c) Call for Proposals 11/2018

The StC defines a financial volume of 970 kCHF for the call for proposals 11/2018. The StC decides on the following scope (thematic focus and indicative duration of projects) of this Call:

- Integration of observation methods (Strategic Priority 1.3): 1-2 years
- Data rescue (Strategic Priority 1.4): 1-2 years
- Earth system cycles (Strategic Priority 3.2): 2-3 years
- Communication of climate observation (Strategic Priority 4.1): 1-2 years

The StC decides that proposals addressing other pillars will also be considered as long as the benefit for the GCOS Implementation Plan and the GCOS Switzerland Strategy are clearly apparent.

#### 9 GCOS Roundtable

The StC decides on the following thematic focus for the National GCOS Roundtable 2019:

- Morning Session: GCOS Monitoring Principles;
- Afternoon Session: Communication of Climate observation.

The StC emphasizes the need to limit the number of participants of the Swiss GCOS Roundtable, by inviting key representatives of partner institutions explicitly.

#### **Outcome of PERMOS discussions**

The StC takes note of the ongoing discussion concerning the renewal of the PERMOS agreement including the possible new contractual set-up encompassing all nine PERMOS partner institutions.
